1. Background

In compliance with the *condition C12 and C13* of the development consent SSD 7256, Cleanaway ResourceCo Resource Recovery Facility (CRRRF) commissioned an Independent Environmental Audit (IEA). This IEA covered the operational period from February 2019 to July 2022 and was conducted in accordance with the IEA program developed by Lead Auditor Mr. Maurice Pignatelli of OptimE. The Lead Auditor competency and the proposed IEA program was approved and endorsed by the Department of Planning as suitable for this audit process.

2. Introduction

This document highlights Cleanaway ResourceCo's official response to the recommendations and improvement opportunities that have been identified to address all non-compliances in the IEA report. This response also outlines the scheduled timeframes and work plans to implement the accepted recommendations.

3. Management Overall Response to Audit Process and Recommendations

The audit process was conducted in an efficient and professional manner that allowed sufficient engagement between the auditor and auditee regarding the recommendations raised.
