CONSTRUCTION & DEMOLITION WASTE CREDIT

Customers seeking to obtain a Construction and Demolition Waste credit towards certification of their Green Star Building Project are required to use waste contractors and waste processing facilities that have been independently-verified for compliance with minimum standards of operation and reporting, as per the GBCA Green Star Construction and Demolition Waste Reporting Criteria.

This means that any waste produced during the construction, renovation, demolition or deconstruction of a prospective Green Star Building project will need to be managed by a verified contractor and facility. These waste materials typically include concrete, wood, metals, plasterboard, cardboard, plastics, asphalt and mixed site debris such as soil and rocks.

INDEPENDENT VERIFICATION OF ENVIRONMENTAL PERFORMANCE & COMPLIANCE

In becoming eligible to provide our clients with a Green Star credit, ResourceCo has been through a rigorous process of obtaining a Verification of Compliance for our resource recovery operations.

An environmental auditor with internationally recognised qualification was engaged to conduct a site audit at ResourceCo's facilities and undertake an assessment of environmental compliance against the following Green Star requirements:

1. 100% compliance with the facility's EPA licence conditions.
2. Auditable systems are in place to prepare accurate reports on the source and fate of inbound and outbound waste received at the facility.
3. Annual reporting is undertaken on independently-verified gross diversion rates of waste from landfill, and the percentage of residual waste committed to landfill from operations.



RESPONSIBLE PRODUCTS CREDIT

Supporting projects in completing the full lap of circularity, ResourceCo can also support its customers with Responsible Products credits towards their Green Star Ratings. From the construction and demolition waste brought by customers to ResourceCo's waste processing facilities, ResourceCo produces a range of recycled aggregate products for supply back into civil construction and infrastructure projects.

To substantiate the circular values inherent in their recycled aggregate products, ResourceCo has obtained independently verified, product-specific Environmental Product Declarations (EPDs). An EPD provides independently verified and quantified data on the environmental impacts associated with a given product at each stage of that product's lifecycle.

Green Star seeks to reward the use of products that are transparent, reduce embodied carbon, and have a lower environmental impact. Clients who use ResourceCo's EPD-verified aggregate products in their projects can be rewarded with Responsible Product Value (RPV) points as part of obtaining a Responsible Products Credit, ultimately contributing to the achievement of a Green Star Rating.
